R4 Alliance – 2014 Program Accomplishments

R4 is an Alliance of Programs of Excellence providing therapeutic and community based recreation, as well as other opportunities, for Our Military Family (OMF). Our members are joining forces to overcome barriers to quality care provision through the following objectives:

- Advocate member driven standards of excellence
- Conduct research proving the efficacy of our services on a national scale
- Provide professional education opportunities leveraging our combined experience and collective knowledge
- Create a continuum of care between service providers
- Ensure the economic viability of our member organizations

In addition to being focused on our growing Membership, R4 Alliance has developed 5 focused programs to meet the above objectives: *Research, Member Driven Standards of Excellence, Education and Training, Continuum of Care, and Economic Viability*. In our first year we have made great gains in each program area.

Research

There is little research proving the efficacy of recreation services for OMF. Past research was with small data sets using different tools. As an Alliance, R4 can conduct large scale research through cooperation between members.

In 2014 R4 began a major research effort in partnership with Clemson University, and corporate sponsorship. Ten R4 members are collaborating using a shared research tool to measure change in: quality of life, relationship satisfaction, Post-Traumatic Stress symptoms, and confidence through recreation participation. The results will be peer reviewed and published.

All research results are leveraged nationally gaining public and private support. Research also helps distinguish practices yielding the most benefit. R4 provides valuable insight to help members evolve their services using effective practices.

R4 continues to increase research efforts and continue building new research partnerships in 2015.

Membership

R4's success depends on collaboration between programs of excellence and their adherence to member driven standards of excellence. Our united voice is strong! Through collaboration we leverage our combined experience and collective knowledge to the benefit of all members. To be sustainable and effective R4 members do not act as independent operators working in silos.

In our first year, R4 Alliance grew from eight founding organizations to over 50 Programs of Excellence nationwide. Our membership has collectively served over 155,000 members of OMF. It is our goal to increase membership to 100 Programs of Excellence in our second year.

Education and Training

All members of R4 Alliance are asked to be transparent and non-proprietary in all practices. By sharing our best practices, collective knowledge, and combined experience, all R4 members benefit.

In 2014 R4 hosted our first annual National Membership Conference to share ideas, and give members a voice in development. Over 35 attendees represented 75% of members, board/administration, and the Office of the Joint Chiefs of Staff. Our second conference will be in October 2015 with 80+ anticipated attendees.

In 2015 R4 will launch a webinar series with different members presenting on their area of expertise. Additionally, in 2016 we will host our first Education Workshop open to: members, students, volunteers, practitioners, and anyone else interested in participating.

Continuum of Care

Non-profit services for OMF are disjointed, and there are no opportunities for providers to collaborate on care plans. Each organization has extensive applications creating a barrier to participation.

R4 is building a Continuum of Care database encompassing all members. OMF will be able to enroll with R4, and share their saved application/profile to whichever organization they choose. This living file eliminates the barrier of applying, and creates a platform for professionals to collaborate on care plans.

R4 partnered with Unite Us to create our Continuum of Care database for implementation 2016.

Economic Viability

This is R4's newest program. While the demand for services grow, often our members are inhibited from extending their reach due to financial constraints. This is compounded by a culture of competing for limited resources.

R4 Alliance develops collaborative fundraising initiatives (such as the Patriots' Parade) to help insure the economic viability of our members. Members are incentivized to participate through sharing proceeds.

As 50+ programs of excellence with one voice, R4 is better positioned to gain corporate support. R4 garnished corporate and member support in 2014 through sponsorship from Higher Ground, Project Healing Waters, Northern Trust, Luna Vineyards, and Century Club. We anticipate increased and more diverse support in 2015.

Any funds R4 acquires above and beyond the program cost of our mission will be given back to members through gifts and grants.
